EXECUTIVE ORDER 15-04

RESCISSION OF EXECUTIVE ORDERS

WHEREAS, certain Executive Orders have been rendered ineffective due to either the enactment of superseding law, subsequent Executive Orders, internal expiration provisions, or are no longer needed for the efficient administration of state government; and

WHEREAS, the existence of obsolete Executive Orders can create confusion on executive agencies and the public regarding the current administrative policies and direction of state government, and are an unnecessary regulatory burden;

NOW THEREFORE, I, Jay Inslee, Governor of the state of Washington, in keeping with the principles of regulatory reform and improvement, declare my commitment to streamline and simplify the operations of state government by eliminating unnecessary, outdated, and conflicting policies and directives of the Office of the Governor. To accomplish that purpose, by virtue of the authority vested in me, I hereby order and direct that the following Executive Orders are rescinded:

EO 77-04, relating to drug abuse;

EO 80-21, relating to the distant waters fisheries advisory council;

EO 81-21, relating to housing financing;

EO 82-22, relating to the Job Training Partnership Act of 1982;

EO 84-18, relating to the athletic health care and training council;

EO 84-19, relating to salmon license fees;

EO 84-21, relating to establishing an interagency economic development coordinating council:

EO 84-22, relating to state administration of industrial revenue bond ceiling control;

EO 87-03, relating to 1987 state ceiling for private activity bond volume;

EO 87-09, relating to establishing a task force on AIDS;

EO 88-01, relating to establishing a committee on Washington's financial future;

EO 88-05, relating to reestablishing the Governor's Alliance Against Drugs;

EO 90-04, relating to the protection of wetlands;

EO 90-06, relating to implementing Washington's environment 2010 action agenda;

EO 92-06, relating to establishing the food processing industry development council;

EO 92-08, relating to establishing a council on physical fitness and amateur sports;

EO 94-01, relating to implementing an energy strategy;

EO 94-06, relating to establishing a family policy council advisory committee;

EO 94-08, relating to establishing a council on families and youth and justice;

EO 97-01, relating to access to government electronic records for commercial purposes;

EO 97-02, relating to regulatory improvement;

EO 97-03, relating to quality improvement;

EO 98-02, relating to training and protocols for state investigators;

EO 00-04, relating to establishing a state alliance to reduce prescription drug spending;

EO 00-05, relating to the federally mandated private activity bond state volume cap;

EO 04-02, relating to establishing the state biodiversity council;

EO 04-03, relating to monitoring salmon recovery and watersheds;

EO 08-04, relating to administering the volume cap authorized under the Housing and Recovery Act of 2008;

EO 09-03, relating to capital stimulus project streamlining;

EO 09-06, relating to tax exempt bond volume caps;

EO 10-02, relating to strengthening the state's food systems;

EO 10-04, relating to ordering expenditure reductions in allotments of state general fund appropriations; and

EO 10-07, relating to performance-based contracts.

This order in no way invalidates the orders hereby rescinded, and these orders shall continue to apply to relevant events occurring prior to this date.
